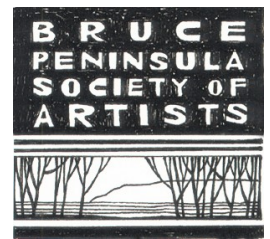


Exhibit Dates - June 6 to September 7, 2020

About the Exhibit

- The exhibit will be held at the Bruce County Museum and Cultural Centre in Southampton. The Museum is a world class exhibition site that we will have for the high season months.
- This will be a juried exhibit. Jurors will be chosen for their knowledge and talent and will not be BPSA members. Decisions of the jurors are final.
- The theme of the exhibit, "Escarpment Roots: The Land, The People, The History" is designed to allow artistic freedom while ensuring cohesiveness and celebrating our beautiful escarpment.
- The exhibit space allows for both 3D free-standing and wall-mounted works.

Fees and Awards

- There is a \$15 entry fee (covers up to 3 works), non-refundable, to enter.
- There are a number of awards that will be chosen by the jurors:
 - Best of Show - \$200
 - Best Painting in any Medium - \$75
 - Honourable Mention - \$25
 - Best Wall-Mounted in other Medium (fibre art, print-making, photography, multimedia) - \$75
 - Honourable Mention - \$25
 - Best 3D Free-Standing - \$75
 - Honourable Mention - \$25

Dates to Remember

- May 01, 2020 - entry deadline
- May 28, 2020 - submitted works delivered to the Museum by the artists between 10am and 4pm
- May 29, 2020 - works juried
- May 30-31, 2020 - artists informed of jurying results
- June 01, 2020 - works not accepted into the exhibit must be picked up from the Gallery by the artists between 10am and 4pm
- June 06, 2020 2-4pm - opening reception
- September 8 & 9, 2020 - artists to remove works from the Gallery

More of What you need to know

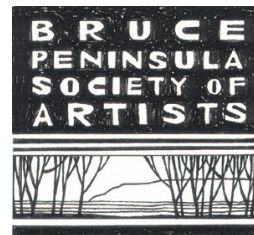
1. All submitted works must be original work of the BPSA member in good standing, and must follow the theme and all entry requirements.
2. No computer-generated graphic art, anything made from a kit or made under a tutor in a workshop or class will be accepted.
3. Artists can submit a maximum of 3 works and a maximum of 2 can be accepted into the exhibit.
4. All work must be for sale and all work MUST remain in the exhibit for the entire time even if sold. No changes or substitutions are permitted.
5. Insurance is the responsibility of each artist.
6. Sales - The Bruce County Museum will take a 20% commission. All sales will be coordinated through the BPSA sales coordinator. The artist will provide permission for sold and paid works to be picked up by the purchaser at the end of the show. Any necessary shipping is the responsibility of the artists.
7. The Exhibit committee reserves the right to disqualify any application not meeting the entry requirements.

Details for Submitted Works

All wall-mounted pieces	<ul style="list-style-type: none">• Image size minimum - combined measurement of one length and one width - 24 inches• Image size maximum - combined measurement of one length and one width - 60 inches• All wall-mounted pieces must be properly wired on the back in order to work with the Gallery hanging system - no saw-tooth hangers
Paintings	<ul style="list-style-type: none">• No unframed matted works will be accepted• Canvas must have finished sides or be framed• Oil painting must be completely dried• No glicee or computer generated prints will be accepted
Photography	<ul style="list-style-type: none">• No unframed matted works will be accepted• If done on canvas, the canvas must have finished sides or be framed
Printmaking	<ul style="list-style-type: none">• Includes etchings, linoprint, mono print• No unframed matted works will be accepted• No glicee or computer generated prints will,be accepted
Fibre Art	<ul style="list-style-type: none">• Must not be from a pattern or kit
Mixed/multi media	<ul style="list-style-type: none">• No unframed matted works will be accepted
All 3D free-standing pieces	<ul style="list-style-type: none">• Includes all sculpture, pottery, wood and other 3D• Must fit on a 14"x14" pedestal (pedestal will be provided)• Maximum height allowable is 3 feet
